Apply Online - Your bond and instructions for completing the online application and oath of office will be emailed to you.

Email, Fax or Mail Commission Certificate - Please email, fax or mail us a copy of your commission certificate. Upon receipt of your commission certificate, we will mail your products within five business days.

• A property owner and a bank sued a Notary. She did nothing wrong, but was deceived by identity thieves. The Notary chose to pay to settle both lawsuits rather than endure prolonged litigation. An Errors & Omissions policy would have protected her.
